We received below request from a customer.

Companies supplying articles containing substances of very high concern (SVHCs) on the Candidate List (<https://echa.europa.eu/candidate-list-table>) in a concentration above 0.1% weight by weight (w/w) on the EU market have to submit information on these articles to ECHA (European Chemicals Agency), as from 5 January 2021.

The SCIP (Substances of Concern In articles or in complex Products) database owned by ECHA (<https://echa.europa.eu/it/scip>) ensures that the information is available throughout the whole lifecycle of products and materials, including at the waste stage.

The system-to-system service (S2S) is available to support companies that wish to prepare and submit SCIP notification dossiers in an automated way. An automatic S2S transfer allows companies that have created SCIP notification dossiers in their own systems to submit their notifications to the ECHA Submission Portal. The IMDS system offers you that possibility (<https://www.mdsystem.com>).

You are kindly requested to declare and notify as from Dec. 11th any products purchased by Empas and containing substances as per the ECHA specification.

This customer only buy the SA1/4IMEG-15055 at Empas so please check for this item if it contain a substances of very high concern as mentioned on the candidate list table.

I assume that for the mentioned item it is not applicable but I need manufacturer confirmation to be sure.
